The Board is pleased to announce the poll results in respect of the resolutions set out in the notice of the AGM.

Reference is made to the notice (the “Notice”) of the annual general meeting and the circular (the “Circular”) of Varitronix International Limited (the “Company”) dated 29 April 2010. Unless the context otherwise requires, capitalised terms used herein shall have the same meanings as those defined in the Circular.

At the AGM, all proposed ordinary resolutions (the “Ordinary Resolutions”) set out in the Notice were taken by poll. The Company’s Hong Kong branch share registrar and transfer office, Computershare Hong Kong Investor Services Limited, was appointed as the scrutineer for the vote-taking at the AGM.

The total number of shares entitling the Shareholders to attend and vote for or against the Ordinary Resolutions at the AGM was 323,422,204 Shares, representing the entire issued share capital of the Company as at the date of the AGM.
